In consideration of the risk of injury while participating in the Nebraska Innovation Studio, and as consideration for the right to participate in the activity, I hereby, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation in the workshop, and release, forever discharge, hold harmless and indemnify Nebraska Innovation Studio, the University of Nebraska Board of Regents, UNL, and NICDC, their employees, affiliates, members, agents, attorneys, volunteers, and representatives, for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in the aforementioned activity, including traveling to and from the event related to this activity.
